in the sum of twenty five thousand Dollars
well and truly to be paid, we bind ourselves
our heirs, Executors and Administrators jointly
and severally to said University this 11th day
of June 1874 - The condition of this obligation
is such that if said David S Cordoe
shall well and truly discharge all his
duties as Treasurer of Kentucky University and
account for and pay over all funds received by
him or now in his hands, and in all things
discharge all his duties as Treasurer as afore-
said according to law, then this obligation
to be paid, else to be and remain in full
force and effect -
